1. Welcome and Annual Report by Dr. R. Peters, Chairman EFRC

The Chairman welcomed all participants.

The current membership count for 2020 is 42 members: 10 operators, 11 OEM's, 9 component suppliers, 4 universities and institutes, 5 consulting companies, 2 engineering contractors, 1 press.

New members in 2019: Wentzel Dynamics joint the EFRC again.

Members, who left the EFRC in 2019: SafeGas, Andreas Hofer (was taken over by NEA) and Southwest Research Institute.

About our association, the EFRC e.V.", the chairman states that "the whole setup is rather unique". In 2019 the EFRC celebrated its 20th anniversary. In August 2019 the former board members of EFRC met in Vienna. Unfortunately Prof. Gotthard Will and Siegmund Cierniak could not attend.

Rene Peters remembered the death of Siegmund Cierniak, who passed away on 21st of November 2019. We will keep him, the 2nd chairman of EFRC, in good memory.

Main results of EFRC activities in 2019/2020:

- The EFRC Training in Delft 2019 was successful
- The R&D Working Group and their Focus Groups are very active
- The Standardisation Working Group started with 8 members in 2020
 → New members, esp. operators, are very welcome, please consider joining.
- The new website ready to be released
- A lot of preparatory work for the EFRC Conference, the EFRC Training and the Student WS is ongoing
- EFRC closed a new trade agreement with Compressor Tech 2: Exchange of membership fee for advertisment.

2. Financial Report by Mr. M. Tanner, Cashier EFRC

Matthias Tanner explains the achievements of last year. He used the in 2019 introduced **new way** to present the number for better clarity. He split the financial overview into the three sections:

- General Part of EFRC (non taxable)
- Conference/Workshop/Training (taxable)
- R&D (taxable)

Mr. Tanner presented the balance sheet and the income statement for 2019 as well as the planning for 2020 and the open member fees.

Overall Profit/Loss: in 2019 the EFRC has got an overall loss of €-68'219,07. As we are negative we don't have to pay tax.

General Part of EFRC:

- We spent more money than we earned. A big position (~ 26 k€) is the financing of the Standardisation work
- On the long run we can't spend more money than we earn
- Consequences: save money for dinner/shows at our own conferences, collaboration with VDMA, save costs from deletion of web shop

Precompetitive Research:

- The negative result is more fictive as it includes WIP and open receivalbes
- The income from last year was put on the bank account
- o R&D is healthy
- Carefully planning of 2020 will avoid negative result
- EFRC Conference/Training/Workshop:
 - The financial result of this section was 2019 slightly negative
 - For this year we consider a webinar training. This could bring in some money

o The Student Workshop had to be cancelled as of COVID-19

Mr. Tanner shows that there is still one open membership fee 2019 from DRESSER Rand. On this invoice there was already a penalty fee of €500,- added.

There were no further questions to this explanation and the financial planning was presented next.

- For 2020 we have to plan with costs of 30 k€ as cancellation costs of the conference
- The board planned income from a training webinar

3. Report of the auditor by Mr. Th. Heumesser

Mr. Heumesser visited the EFRC Office for the annual audit. He thanked Ms. Maja Schütz for the excellent bookkeeping. All bookings have been done properly.

EFRC paid a lot of money in 2019 (~2.000 €) for banking fees, costs from the shop etc. Here we could save money. → as we didn't implement the shop anymore in our website we will save costs for payments via shop (author's note).

Payment behavior was in 2019 much better than in previous years. But collection agency had to be used again.

Mr. Heumesser again explained both different accounts of EFRC and emphasised the need to split the payments:

R&D Working Group payments to the R&D account:

The aim is to avoid work for shifting the money from one account to the next.

4. Agree on budget & Vote on release of the board & Vote for the 2nd auditor

Release of the board:

Mr. Heumesser advised the board to be released, voting on this was done:

Total Votes: 24.

The board was released.

Questions in the chat have been immediately answered by the EFRC team.

Vote for the 2nd auditor as well as for the agreement on the budget for 2020 have been postponed to the end of the meeting but for logical reasons will be placed here:

Vote for the 2nd auditor:

The board and Mr. Heumesser explained that the 2nd auditor only needs to replace the 1st auditor when he will not be able to perform the audit. Mr. Alexander Peters from Neuman & Esser volunteered to be the 2nd auditor as he already had been some years ago.

Total Votes: 27.

The board thanked Mr. Alexander Peters for volunteering. Mr. Peters accepted the vote.

Vote for the budget for 2020:

Pro: 20 Contra: 0 Neutral: 3

Total Votes: 23.

Matthias Tanner answered a question from Wijnand Schoemakers in the chat regarding the support of the Standardisation Group through EFRC again. He pointed out that the board decided to use the planned 20k€ for the student workshop for the support of the Standardisation Group.

The budget for 2020 was agreed. Mr. Tanner thanked for the trust and hold out a handover in the way that things will go smoothly forward.

Reports of the working groups and outlook

5. Standardisation by Mr. A. Eijk, Chairman

Mr. Andre Eijk gave a short update on the achievements from 2019.

- The constitution of the new official Standardisation Working Group happened
- Important documents like charter etc. have been defined
- The new WG consists of 8 members bringing 37.5 k€
- 5 ideas for new projects, i.e. new guidelines
- In April 2020 new report on the "Inventory of Emissions of Reciprocating compressors" was released → articles and advertisements in CompressorTech2, Gas Compression Magazine and LinkedIN are planned

Mr. Eijk presented items on standardisation and guidelines regarding API 618, API 688 and ISO TC project: "condition Monitoring of Reciprocating Compressors". The last mentioned project can only be a success if recip experts – EFRC members – will join the group. Mr. Eijk encouraged the EFRC members to **join this project group.**

Mr. Eijk stated what will be done in 2020:

- Election of new chairman
- New project: "Flow metering errors in pulsation flow"
- Webinar for Standardisation Group members. The frist webinar of the new WG will be open to all members

Matthias Tanner presented the CV of Paul Modern who volunteers to become the new chairman of the Standardisation WG.

Vote for Mr. Paul Modern as Chairman of the Standardisation Working Group

Pro: 22 Contra: 0 Neutral: 0

The total votes of 22 votes showed that again not all participants have voted.

Mr. Paul Modern was elected for being the new chairman. Congratulations via chat.

The board thanks Andre Eijk for all his work in setting up the standardization group.

6. Pre-competitive research by Dr. M. Langela, Chairman

Mr. Marc Langela took the word and presented the R&D Working Group update.

- 20 members in 2020
- Budget for R&D Work in 2020: 166 k€
- 5 active projects in progress, nearly finished
- Very efficient and successful R&D online meeting the day before. M. Langela thanked all 15 participants.
- 6 new proposals have been discussed in the online meeting the day before. The voting is open now for the R&D Group itself

Mr. Langela presented the 5 active projects:

- a. Andre Eijk (TNO) is very active in the Survey about compressor reliability.
- b. Split Packing Housing by TU Dresden. This is a new concept of designing a piston rod packing
- c. Improved Ring Concept (IRINCO) by Wentzel Dynamics deals about temperature distribution at the sealing ring across the rod and how to improve it

- d. Toroidal Damper Project by TNO and Wentzel Dynamics is about new damper concept
- e. Anomaly Detection by Can Tümer, TNO deals about analysis of compressor data in order to find anomaly compressors datas

Mr. Langela presented the six new project proposals:

- a. Constrained Layer Damping for SBC (small bore connections) byTNO viscoelastic material is used for improvements regarding piping
- b. New Laser Technologies for Recips by TU Dresden lot of different laser technologies outside. Which LT are applicable for reciprocating compressors?
- c. Improved Ring Concept phase 2 by Wentzel Dynamics includes new temperature measurements and improvement of the calculation model
- d. Remaining Useful Lifetime (RUL) by TNO analysing data in order to get a good estimation of the remaining lifetime of a product
- e. Split Packing Prototype phase 2 by TU Dresden includes production of such a split packing and physical testing at a test compressor
- f. Oil film Detection by Wentzel Dynamics detection of the oil within a cylinder to ensure correctly done lubrication

Jost Anderhub from PROGNOST asked about current members in the RUL project group. Mr. Langela answered that only TNO joins as this is a project by TNO but that in other projects R&D members support the executing party.

Later Mr. Langela showed the upcoming meetings and tasks. He hopes that the group can meet physically on October, 30th, in Stassfurt at STASSKOL. The results of R&D projects will be presented at the next EFRC Conference. The R&D Charter will be finalised in October.

Universities are invited to the group and the meetings free of charge to generate additional ideas.

Annual work plan

8. 12th EFRC Conference 2020 Warsaw by Mr. Ch. Prinz on behalf of Ms. A. Parnigoni (task force lead)

Christian Prinz welcomed everyone and spoke on behalf of Ms. Anja Parnigoni who leads the Conference Task Force.

Christian Prinz announced that the EFRC Conference had to be postponed for safetyand financial reasons to March 9-11, 2021. Unfortunately the cancellation costs will eat up our buffer of 30 k€ we usually have for the conferences. But the risk to execute the conference this year would be much higher.

The organisation team already acquired 7 conference sponsors and some exhibitors. Mr. Prinz asked the conference sponsors to do their payments in Q4/2020 or Q1/2021.

New call for sponsors and for exhibitors after the summer break in Q4/2020 or Q1/2021.

Mr. Prinz gave a short preview of the programme. This time EFRC switches to the days Tuesday – Thursday instead of the traditional days Wednesday – Friday to avoid the rush out on Friday from 2 o'clock.

Question: Will the papers review continue? Answer: Yes. In agreement with Prof. Herbert Steinrück, lead of the papers review, they decided to keep the papers as they are. There will be no reissue of the call for papers.

In the chat Prof. Steinrück stated that the paper review deadlines will be kept as they are. All reviewers should deliver in time.

9. Point of discussion joint VDMA conference and Participation at KRMS conference by René Peters, chairman

Rene Peters, chairman of the EFRC, explained the need for a vote for a joint conference with VDMA. The next joint Conference with VDMA (International Rotating Equipment Conference) was planned for 2022. See MoM from GA 2019. As we had to postpone our EFRC Conference from 2020 to 2021 the opinion of the EFRC members id needed if they still feel comfortable with a joint Conference with VDMA in 2022:

Gunther Machu points out that there are 35 companies with 32 votes in the call. He asked participants to raise hands if they have problems with voting.

Vote for a Joint Conference with VDMA in 2022:

Pro: 26 Contra: 1 Neutral: 1

Total votes: 28.

Rene Peters announced that EFRC will continue discussions about the collaboration with VDMA.

Vote on participation of EFRC at KRMS/Cooperation with KRMS was deleted as the GA already voted on that in 2019.

10. Marketing by Gunther Machu, secretary and Maja Schütz, office manager

Gunther Machu reminds members on the call for candidates for the marketing manager position because Martina Frenz had to resign from this position. Some people like A. Parnigoni, Ch. Prinz and M. Schütz jumped in help to fulfill the tasks short time. But it would be very beneficial for our association if we would have a dedicated Marketing Manager to push advertising, to push the recognition of our association.

The call for candidates is still ongoing. Please volunteer and help. Please send CV. The voting for this positions can also be done subsequently online.

Our organisation can only progress if people are willing to take leading positions. EFRC is all about us!!

The presentation of the new EFRC website by Ms. Maja Schütz followed. Ms. Schütz first of all thanked the website team consisting of Anja Parnigoni, Christian Prinz, Marc Langela, Emanuela Turriano and Davide Pozzoni (both from SIAD) as well as the website agency, Domeniceau Design. She shortly pointed out the main achievements of the work for the new website.

Then Ms. Schütz demonstrated and explained the design, structure and content of the new website. She also showed new and old features and plugins.

The new website was received very well and members released many positive comments in the chat.

Mr. Tanner furthermore pointed out that with the new website EFRC also saves money through the change of the supplier, through a maintenance package with Domeniceau Design, trough using free software and through deletion of not needed additional domains. He thanked Ms. Schütz for the brilliant work.

Jost Anderhub from PROGNOST asked if the content of the TUTORIAL section also has been refreshed. Ms. Schütz answered that a student of a higher degree is working on this. Christian Prinz emphasized the need for the input from the members for the tutorial section. Every member should approach Maja with updated information and new technologies.

Answering a question from Leonard van Lier about the continuation of the web shop Matthias Tanner stated that the board decided to delete the web shop as the costs for the shop and the payments were not in balance with the amount of members who used it.

11. Vote on EFRC Board positions

Gunther Machu took the word and stated that all positions are open again and all three board members already did a full term or more. The board tried to find successors in a call for candidates which Ms. Schütz sent our several weeks ago.

Mr. Machu said that Franzisko Maywald from Burckhardt Compression volunteered as candidate for the position of the Cashier.

Unfortunately, there were no applications for the other board positions so *Gunther Machu* and *René Peters decided to do one more year as secretary resp.* as chairman. René Peters pointed out the benefit of "fresh people" for the association.

EFRC was financially very successful thanks to Matthias Tanner. Mr. Peters expressed his hope to hand over a present in a face-to-face meeting next year. He trusts that Matthias has selected a very good successor.
